Instructions -

1. School Fee calculation is implemented on UP Fee Regulation Act. 2018.
2. **1st Quarter Composite Fee with exam fee must be deposited upto 10.04.2020 in vijaya bank, Aligarh. A/C No. 712001010008787 IFSC Code – VIJB0007120 by cash or by RTGS/NEFT. All fees are payable in advance on quarterly basis i.e. in April, July, October and January on or before 10th of the starting month of each quarter. a fine of Rs.5/- per day to a minimum of Rs.50/- will be charged after the due date upto last day of the same month, after which the name of students will be stuck off from the roll and full admission fee will be charged on Re-admission.**
3. Deposit of entire composite fee full session upto 30th April, 2020 and get concession @ 2 % if paid upto 30th April, 2020.
4. All Fee are non refundable.
5. Cost of students diary is Rs.100/-.
6. Normally school will charge 12 months tuition fee for one academic session (April to March).
